




Doghouse of modern design is painted to match the owner's Los Angeles house. A divided canvas door lets the dog squeeze in and out, yet keeps out the wind


The dog likes it fine

No run-of-the-mill doghouse, this. The gaiety of its appearance arises in part from the ingenuity of its construction. The two ends are fashioned of equilateral triangles of the same size. The two roof sides have the same dimensions as the floor. A glass window lets in light.

This kind of construction made the doghouse easy to cut out and assemble. It is painted to harmonize with the home of the designer and builder, Norman C. Bilderback. Hinged at one side to the deck, the house opens up for cleaning.

Peak and base are 2 by 4's; all other framing is of rip-sawed 2 by 3's. The floor and sides are of 1/2-inch plywood (circles are painted on). Rear window is of glass
